**Release, Hold Harmless, Parent/Guardian Indemnification Agreement and Agreement Not to Sue**

**Liability Information**

In consideration for myself and my minor children being permitted by the Knight Foundry Alliance and the City of Sutter Creek (Owner) to participate in activities associated with the CBA blacksmithing workshops conducted by the Knight Foundry Alliance at the Historic Knight Foundry site located at 81 Eureka Street, Sutter Creek, California starting on January 1st, 2024 (hereinafter Activity or Activities), I hereby waive, release and discharge any and all claims and damages for personal injury, death or property damage which I or my minor children may sustain or which may occur as a result of mine or my minor children’s participation in these Activities.

**I understand and agree that:**

1. This release is intended to discharge in advance the Knight Foundry Alliance and the City of Sutter Creek, its/their officers, employees, volunteers and agents from and against any and all liability, except for their willful negligence or intentional acts, connected in any way with the participation of myself and/or my minor children in these Activities.
2. My participation is voluntary. I understand and acknowledge that the Activity I am about to voluntarily engage in as a participant has certain risks including, but not limited to, environmental, chemical, and physically hazardous. I understand these risks known or unknown, anticipated or unanticipated, may result in injury, death, illness, disease or damage to myself or my property, or to other persons and their property.
3. Knowing the risks involved, nevertheless, I voluntarily request permission for myself and/or minor child to participate in the described Activities. I hereby assume any and all risks of injury, death, illness, disease or property damage and agree to release and hold harmless, and agree not to sue, the Knight Foundry Alliance and/or the City of Sutter Creek, its/their officers, employees & agents, except for their willful negligence or intentional acts.
4. This release, hold harmless, parent/guardian indemnification agreement, agreement not to sue and assumption of risk are to be binding on the heirs and assigns.
